## II. Market Wrap-up

As of the end of January 2025, the total number of TWSE-listed companies stood at <u>1,034</u>, an increase of <u>3</u> over the preceding month. Authorized capital was NT\$ <u>7,827.96</u> billion, an increase of NT\$ <u>4.08</u> billion over the preceding month. Market capitalization was NT\$ <u>75,531.32</u> billion, an increase of NT\$ <u>1,632.65</u> billion over the preceding month.

There were <u>840</u> TPEx-listed companies, an increase of <u>2</u> over the preceding month. Authorized capital was NT\$ <u>798.18</u> billion, an increase of NT\$ <u>2.73</u> billion over the preceding month. Market capitalization was NT\$ 6,544.21 billion, an increase of NT\$ 7.65 billion over the preceding month.

The total trading value in the centralized stock market was NT\$ 4,852.99 billion, a decrease of NT\$ 2,469.72 billion from the preceding month. The trading volume was 42.21 billion shares, a decrease of 27.22 billion from the preceding month. The net value of inwardly remitted foreign funds was US\$ 284.123 billion, an increase of US\$ 811 million over the preceding month.

There were <u>64</u> securities firms, <u>15</u> futures commission merchants, <u>38</u> securities investment trust companies, and <u>88</u> securities investment consulting companies.

為提升投資人透過證券商申購基金之申購價款匯撥方式之彈性,以便利投資人申 購基金,金管會於114年1月8日發布修正「證券投資信託事業募集證券投資信 託基金處理準則」第24條,開放證券商以投資人名義申購投信基金,依證券商 管理規則第38條第2項所定證券商交割專戶客户分戶帳之規定辦理款項收付 者,不受申購價款應由申購人直接匯撥至基金專戶之限制。
